1. Confirmation of Previous Meeting Minutes

The meeting minutes of the Village Owners' Committee (VOC) Meeting No 2 on 14 September 2010 was approved and the Chairman signed the minutes.

2. Management Report

CM advised the Committee of the following village operations:

2.1 Replacement of lobby lightings with energy saving fluorescent tubes Replacement of lobby lighting with energy saving fluorescent tubes to all typical floor lobbies and main lobbies were completed in early October.

2.2 High pressure water jet cleaning of outdoor area

The work was scheduled in mid-December and would focus on underground piping. It would become a regular cleaning item and the frequency was set to twice a year.

2.3 Proposed CCTV viewing village ingress

CM would further study the technical viability as well as the cost of the work, therefore more up to date information would be provided in the next VOC meeting.

2.4 <u>Lift operation</u>

The lift maintenance contractor Fujitec had confirmed there was lift by-pass senor installed in the original design and Fujitec would review the setting on 9 December in order to reduce the waiting time during peak hours, if possible.

3. Matters Arising from Previous Minutes

3.1 Request for Bus Stop in front of Hillgrove

CC mentioned that the issue had been conveyed to Transport Division at the recent City Owners' Committee (COC) Meeting. Transport Division concurred to study the proposed temporary bus stop being operated in off-peak hours for outbound routes. CM would follow with Transport Division.

3.2 Update Progress of Installation of Motion Senor

Price comparison of motion senor was presented, but VOC commented that it should be a city-wise exercise and requested the Chair to raise the subject during the next COC meeting.

4. Update on Outstanding Issues of Renovation Project

Members asked if there were any outstanding cases of monies not yet refunded to owners who had installed the balustrade by themselves. CM would check with Finance and Accounts Department on records beyond the past three years and advise the Committee after the Meeting.

5. <u>Discussion on Upcoming Renovation Project</u>

The workflow of selecting consultancy firm was presented. The Committee agreed in principle to the process of a two-envelop system with a scoring ratio of 70% of technical aspect and 30% of pricing. The Committee also requested CM to send out the Renovation Working Group (RWG) membership invitation by next week and preferred to start the process in mid-January. The RWG Convener would normally be one the VOC Members and all owners were welcome to join the RWG. CM would provide a preliminary timetable in the next meeting.

Members suggested several items to be included in this renovation:

- i) Roof waterproofing refurbishment;
- ii) Lift programming (supposed to be studied and executed by the nominated maintenance contractor Fujitec);
- iii) New paint for facade in a lighter and nature tone;
- iv) Architectural treatment at street level including entrances and outdoor / landscape area;
- v) Lift door renewal; and
- vi) Floor lobby flooring and paint and lobby lightings.

Members were welcome to give their inputs to CM for consolidation and these suggestions would be further discussed in RWG once formed.

6. Financial Status

According the last record as at 31 October, it was noted that the expenses were in line with the budgeted figures. A surplus of about HK\$40,000.00 from the saving in City Expenses was achieved.

7. Report on previous City Owners' Committee (COC) Meeting

7.1 Election of Chairman

Mr Collin Bosher was re-elected as the Chairman of the new term.

7.3 Electrical Bus

After the presentation of Discovery Bay Transit Services Limited in the previous meeting, an electrical bus was delivered to Discovery Bay for exhibition in the coming weekend.

7.4 Road Usage License and Vehicle Entry Fees

The new rates were introduced with effect from 1 October. For Vehicle Entry Fee, it was expected to generate an additional income of about HK\$85,000.00 each month in Road Fund.
