Report on Financial Status 2.

2.1 Report on the Village Accounts

JA delivered a brief report on the financial status of Hillgrove. JA commented that the accounts were in a healthy position after the management fee review last year. As there was a surplus generated in the first quarter of the current financial year, the need of a further review of management fee was minimal. The cash had been maintained over a level of HKD10 million while part of which would be utilized to finance the upcoming renovation project.

Progress of Consultancy Services on Tender of Main Contract 3.

The Renovation Working Group meeting was to conclude and to recommend the 9 nos of qualified tenderers to be invited for tender. Key points of tender documents were also presented for discussion and confirmation. Latest programme was presented at the meeting. The consultants presented that the project was behind schedule by two months. CM reminded that there should be a two-week road show for the residents / owners at the Village before the owners' meeting confirming the final scope of work and the appointment of main contractor.
