1. Confirmation of Previous Meeting Minutes and Recording of Meeting

2. Resolution on "To defer the Annual General Meeting 2017-2018 in order to combine with the vote needed on the forthcoming building works"

According to the Deed of Mutual Covenant and its sub-deed, an Annual General Meeting was supposed to be held in each calendar year. In view of the resource required for conducting the owners' meeting and the progress of the renovation tender with a closing on 13 December, followed by an analysis prepared by the consultants, it was recommended that the meeting would be deferred to a date after VOC's review of the analysis. A report from VOC on the analysis would then be produced for the owners' meeting endorsement of renovation.

In the agenda of this Meeting, owners were invited to give their comment on this resolution, and no adverse comment was received todate.

The Committee unanimously voted for this resolution and this resolution was approved.

The Committee would meet in the mid of January 2018 to review the renovation tender analysis, after which a report would be publicized for Hillgrove owners. The date of the Annual General Meeting would be confirmed where VOC election and endorsement of renovation contract were being resolved.
